

MINUTES

Regular Meeting of the West Chicago Board of Park Commissioners in the Park District ARC Center Meeting Room 105 201 W National Street, West Chicago, IL 60185.

Tuesday, November 12, 2019 6:30 p.m.

I. Call to Order and Roll Call

The meeting was called to order at 6:30 p.m. Present were Commissioners Bass, Gunderson, Lenertz, Spencer, Turney and Voelz, Director Major, Superintendents Gasparini, Hoffmann and Radun. Absent was Commissioner Zaputil.

II. Pledge of Allegiance

III. Presentations

- A. Lauterbach & Amen, LLP Brad Porter presented the Management Letter and Year End Financial Statements to the Board. Mr. Porter thanked Superintendent Hoffmann and her team for the excellent implementation job throughout the audit process. Key points covered were:
 - Opinions The district received an unqualified opinion, which is the cleanest form of opinion available.
 - Recommendation from FYE 2018 were all implemented in FYE 2019 and there are no new recommendations.
 - General fund: +\$139,000
 - Rec fund: -\$234,000 reason for decline noted in comments as 10% decline in revenue, absorption of bond debt, unforeseen repairs, etc.

Commissioner Spencer inquired as to how bonds work and if they are similar to a home mortgage. Mr. Porter explained that while bonds are similar to a home loan the difference between the two is a refinance on a bond is not necessarily resetting the amortization schedule and is typically only done when it is advantageous or there is an immediate capital need. Superintendent Hoffmann stated our financial consultants reach out to us if there is an advantageous reason to refinance a bond based on the life of the bond. Mr. Porter noted the District's current debt margin is within standards and outstanding debt will continue to decrease as principal is paid down.

IV. President's Comments

President Lenertz expressed apologies for his absence at the Don Earley Park dedication and thanked staff for the great job in putting the dedication together. President Lenertz received many calls and emails of supportive feedback regarding the park dedication decision. The community was well represented at the dedication and Mr. Earley was grateful.

President Lenertz thanked staff, commissioners for a job well done at Boo Bash. The event provided a great and fantastic experience for the 500+ attendees.

VIII. Expenditures

The Board reviewed the Expenditures for August 2019 with staff.

Page 81 – ComEd for Zone250 in the amount of \$2,058.54 - Bass/Gasparini. Is the high bill a result of higher use at Zone250 since the amount is so close to ARC amount. In part, yes but it should be noted that the ARC bill is actuall double the price listed as half the ARC electricity is billed by ComEd (delivery) and the other half is billed through Mid America (usage).

Page 87 – NicorGas for 830 W Hawthorne building in the amount of \$116.60 – Lenertz/Gasparini. The low cost is attributed to the fact that the bill is for late August / early September.

Page 89 – PNC Equipment Finance, LLC in the amount of \$920.39 – Spencer / Gasparini. This is a monthly lease bill for 2 mowers on a 3-year lease agreement. The cost of each mower outright would be \$30,000.00 each. At the end of the lease the District is given the opportunity to purchase the mowers at current value or turn them back in. The lease agreement does not include parts and labor.

Page 92 – Vermont Systems, Inc. in the amount of \$6,789.20 – Voelz/Medeiros. This is for the cost of Vermont Systems to be on site during migration.
